

## **BUD LIGHT® NFL FLYAWAY SWEEPSTAKES - OFFICIAL RULES**

1. NO PURCHASE NECESSARY.

2. The “Bud Light NFL Flyaway Sweepstakes” (“Sweepstakes”) is open to residents of the fifty (50) United States and District of Columbia who are twenty-one (21) years of age or older at the time of entry. Void where prohibited.

3. Sweepstakes begins at 12:00:00 a.m. Central Daylight Time (“CDT”) on September 1, 2019 and ends at 11:59:59 p.m. CDT on October 31, 2019 (“Sweepstakes Period”).

Text message

entries will be deemed to have been submitted by the registered owner of the wireless number used to enter. In the event of a dispute regarding the identity of an online entrant, the authorized subscriber of the email account used to enter will be deemed to be the entrant, and must comply with these rules. The authorized account subscriber is the natural person who is assigned the email address by the ISP or other organization responsible for assigning email addresses. The potential winner will be notified by phone and/or email and will be required to respond to the notification within twenty-four (24) hours indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate potential winner will be randomly selected (time permitting). Any alternate potential winner selected will also be required to respond to the notification within twenty-four (24) hours.
